





# **History & General Information**

# Marine Corps History - SEPTEMBER & OCTOBER







5 October 1775 / Word "Marines" used on the earliest known occasions at a meeting in Philadelphia during second Continental Congress. General George Washington gave orders for the "proper encouragement to the Marines and seamen" for their service on U.S. armed ships..

6 October 1945 / Major General Keller Rockey accepted the surrender of 50,000 Japanese troops in North China on behalf of the Chinese Nationalist government.

11 October / A Marine Battalion was flown to a frontline combat position for the first time during Operation Bumblebee, northeast of Yanggu, Korea.

28 October 1962 / One week after the Marine Corps was put on alert, the 5th Marine Expeditionary Brigade left Camp Pendleton for the Caribbean during the Cuban Missile Crisis. Also, the 1st and 2nd Marine Divisions were sent to Guantanamo Bay to reinforce those already there. Other units were deployed to Key West, Florida.

23 October 1983 / The BLT headquarters building was destroyed in Beirut, Lebanon killing 220 Marines as well as others

# **MCL Department of Florida Information**

**Fall Conference 2015** 29 October - 1 November 2015 at Palm Beach Gardens, Florida.

There are currently 50 Detachments. Our District 2 includes three Detachments: Gator Detachment 990, Tri-County Detachment 1086, and St. Maj. Briggs Detachment 1018.

The Department has 672 delinquent members (although some of these may be from reporting problems as our Detachment has experienced). The Junior Vice Commandant is working on preparing Recruitment Retention and Mentoring Program Guidelines.

There are now 46 Detachments with a Boy Scout / Eagle Scout program. So far this year, 402 certificates have been presented.

Lou Calleja (Jr. Past Commandant) is to be Director of the Leadership School. This Fall's Leadership class had 110 students (80% new students).

Scholarship Fund 2014 had \$1,700 and 32 applicants. The Fund for 2015 was below what was expected.

Detachments have given \$72,000 to the Injured Warrior Fund of Florida. So far, \$58,000 of that has been paid out.

Florida drivers licenses will now spell out the word Veteran on the license instead of just having the letter V. These licenses must be requested and a DD-214 is required.



## **MCL National Information**

The NEW national website is up, but still under construction.

NEW Officers were elected at the National Convention held 9-15 August 2015 in Scottsdale Plaza Resort, Scottsdale AZ and are listed in the sidebar.

The NEW national Veterans ID Card law (P.L. 114-31) passed both houses of Congress and was signed by President Obama July 20. It is intended to be a more convenient form of proof of service than having to carry around the DD-214 and will not be used to obtain any VA services. To receive this ID Card you have to provide a DD-214 or other military service record and be honorably discharged. There will be a fee. As yet, they are not ready for distribution. The MCL will need to determine if the new ID Card will be an acceptable alternative to the DD-214 for membership. Our Gator Detachment Officers have decided to continue requiring the DD-214.

Camp Lejeune water contamination health benefits are available if you served there between 1 August 1953 - 31 December 1987. This includes service members and their families. A number of medical conditions qualify. If you want more information or help with qualifying, you can contact the VA or the Alachua County Office of Veterans Services (352-264-6740).
